By signing up for the Shazam Bolt\$® app, you will automatically receive email alerts 24/7 whenever a debit card purchase is made. You can customize your debit card transaction threshold so when a transaction occurs over the dollar amount you set; you will receive an email or text notification of the details of your purchase. To get the Shazam Bolt\$® app, visit either the Apple App or Google Play store to download the Bolt\$® app to your smartphone or tablet.
