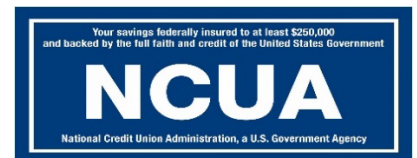

Home Equity Line of Credit (HELOC) loans are available for primary and second homes in MN and WI. Closing costs range from \$250 to \$1,200, depending on the loan amount. The minimum loan amount is \$10,000. Payment example: For a \$35,000 loan with a 5-year term, based on up to 80% of the County Tax Assessed Value at a fixed rate of 5.99% Annual Percentage Rate (APR), the monthly payment would be \$676.53. Rates are subject to change at any time. Some housing exceptions and other restrictions may apply.
